## LIST OF QUALIFYING COUNTRIES IN WHICH COMPANIES, OTHER ENTITIES OR INDIVIDUALS CAN QUALIFY TO OWN A CAYMAN FLAG VESSEL

## To: OWNERS, MANAGERS, CHARTERERS AND MASTERS OF ALL CAYMAN ISLANDS SHIPS (INCLUDING PRIVATE AND COMMERCIAL YACHTS)

## 1. BACKGROUND

1.1 In accordance with the Cayman Islands Merchant Shipping Law (2016 Revision) (MSL 2016), entities that are eligible to directly own a Cayman registered vessel (without forming a Cayman registered Company), include bodies corporate, shipping entities or citizens of the countries as listed in this Notice.

A. Countries which are either<sup>1</sup> Members of the European Union (EU), the European Economic Area (EEA) or which are included in The Anti-Money Laundering Regulations 2017 or AMLRs (repeals and replaces Schedule 3 of the Cayman Islands Money Laundering Regulations (2015 Revision) or Third Schedule Countries)<sup>2</sup>-
