

SHIPPING NOTICE 02/2021

TECNICOMAR ECOMAR SEWAGE TREATMENT PLANTS.

To: OWNERS, MANAGERS AND MASTERS OF CAYMAN ISLANDS SHIPS and CAYMAN ISLANDS RECOGNIZED ORGANIZATIONS.

1. BACKGROUND

- 1.1 In February 2019, MED certification approval was withdrawn for certain Tecnicomar sewage treatment plant products, a full list of which is provided in Annex 1.
- 1.2 An evaluation of a risk assessment for the affected equipment by the UK MCA has concluded that these models have the potential to pose a risk to the marine environment, meaning that corrective action must be taken by the manufacturer (Tecnicomar S.p.A.) in order for the equipment to remain in use and not be removed from vessels. In response to the withdrawal of certification, Tecnicomar S.p.A. has gained certification from DNV-GL, on behalf of the Norwegian Administration, for a new range of equipment (ECOMAR-S range) and is currently seeking certification of an upgrade kit which would enable the impacted models to regain certification.

2. EXISTING UNITS

2.1 As the listed equipment is currently uncertified, vessels that have the equipment onboard risk being unable to renew their Sewage Pollution Prevention certification (Statement of Compliance) when their existing Statement of Compliance expires. To maintain the validity of certification, shipowners and operators must liaise with Tecnicomar S.p.A. to agree and arrange for the replacement or upgrade of the non-compliant equipment.

3. RECERTIFICATION

- 3.1 All uncertified equipment must be replaced with equipment certified in accordance with MEPC.227(64) before the renewal of the International Sewage Pollution Prevention Statement of Compliance.
- 3.4 Where equipment has been modified to comply with MEPC.227(64) the certification must clearly cover the entire installation, as modified.
